Dance Theme School of Dance Release Form

- A **non-refundable** registration fee is due and payable at the time of registration. This guarantees placement in class.
- Fees are an annual tuition.** For your convenience, monthly payments can be made. For example the annual tuition for a one hour class is \$530.00. This can be broken into 9 monthly payments if you prefer. The first month would be \$106.00 and then \$53.00 per month for the remaining 8 months. **Fees are due the first of each month (Sept. - June).** June fees are payable in full.
- There are 36 classes in the year. For classes that are entered in festivals or competitions they will receive 35 classes per year.
- First and last month's fees are payable at the time of registration if your monthly fee is \$75.00 per month or less. **These fees are non-refundable.**
- Written notice submitted to the office is required to withdraw from class, otherwise billing to your account will continue. If notification is not received in due time, the next month's fees will be billed and processed. These fees **are non-refundable.**
- A non-refundable costume deposit will be collected in November. Dancers will be responsible for the cost in full of all costumes ordered on their behalf. Fees must be paid prior to students receiving costumes.
- Notices to parents for students involved in competitions and festivals are issued in November and applicable fees are invoiced. Once a dancer has been entered in a competition or festival, they are responsible for the cost of their entry fee. Entries are submitted and paid for on your behalf in November.
- For your convenience we accept Visa, Mastercard, debit, cheques and cash. Automatic monthly credit card payments can be arranged. Forms are available in the office.
- There will be a \$15.00 service charge on NSF cheques.
- Overdue monthly fees are subject to a \$5.00 per month late fee. A client will not be notified prior to applying late fees. It is a client's responsibility to ensure their account is paid in full.
- Dance Theme's main form of communication is via email. Please ensure that you have an updated email address on file and that you check your email frequently. Newsletters are posted on our website.
